Therefore, as per letter No.A-12025/1/2007-ESA(LB) dated 18.04.2017, he will draw pay in the level 7 of the pay matrix w.e.f. 25.06.2017 and all the relevant allowances should be regulated accordingly.
- In pursuance of Ministry of Finance, Department of Expenditure's GSR 721(E) dated 25th July, 2016 and resolution issued vide No.1-2/2016-IC dated 25th July, 2016, the pay of Shri Reji B is hereby re-fixed as per the respective Level in the pay matrix in terms of the recommendations of the 7th Central Pay Commission's report w.e.f.01.01.2016.

- This order supersedes all the previous pay fixation orders issued including Office Order No. 69 of 2018 dated 23.02.2018 and 424 of 201 20.12.2018.
- It is clarified that since Shri Reji B has performed duties related to AD (Ex-cadre) during 25.06.2016 to 18.04.2017, he is entitled to draw salar for 25.07.2016 to 18.04.2017 in terms of recommendation of specially constituted committee, as accepted by the competent authority.
