OFFICE ORDER No. 153 of 2019

In partial modification of Office Order No.424 of 2018 dated 20.12.2018, consequent upon grant of 1st MACP to Shri Reji B, Investigator Grade-II of Labour Bureau, Chandigarh w.e.f. 02.06.2013 in the pre revised Grade Pay of Rs.4600/-, and in supersession of all previous orders consequent upon his adhoc promotion to the post of Senior Statistical Officer w.e.f. 29.07.2013 and subsequently appointment on deputation basis to the post of Assistant Director (ex-cadre) w.e.f. 25.07.2013 and the decision of the competent authority to treat him as reverted from the deputation post of A.D.(Ex-cadre) w.e.f. 18.04.2017, the pay of Shri Reji B, Investigator Grade-II is re-fixed as under:

2. Shri Reji B, Investigator Grade-II was holding the post of Statistical Investigator Grade-I/SSO on adhoc basis w.e.f. 29.04.2013 to 24.07.2013 and the post of Assistant Director (Ex-cadre) on deputation w.e.f. 25.07.2013 to 24.07.2016. Therefore, as per letter No.A-12025/1/2007-ESA(LB) dated 18.04.2017, he will draw pay in the level 7 of the pay matrix w.e.f. 25.06.2017 and all the relevant allowances should be regulated accordingly.

3. In pursuance of Ministry of Finance, Department of Expenditure's GSR 721(E) dated 25th July, 2016 and resolution issued vide No.1-2/2016-IC dated 25th July, 2016, the pay of Shri Reji B is hereby re-fixed as per the respective Level in the pay matrix in terms of the recommendations of the 7th Central Pay Commission's report w.e.f.01.01.2016.

4. The fixation of pay and payment of arrears and/or recoveries arising thereof, if any is subject to adjustment in the light of audit objections that may come to light later on.

5. This order supersedes all the previous pay fixation orders issued including Office Order No. 69 of 2018 dated 23.02.2018 and 424 of 2018 dated 20.12.2018.

6. It is clarified that since Shri Reji B has performed duties related to AD (Ex-cadre) during 25.06.2016 to 18.04.2017, he is entitled to draw salary for 25.07.2016 to 18.04.2017 in terms of recommendation of specially constituted committee, as accepted by the competent authority.
